I hereby assume all risks of injury, loss of life, and damage to persons or property (including pets). I further release, indemnify, and hold harmless, including without limitation The Holt County Agricultural Society/Holt County Fair. Officers, Directors, Staff, and Volunteers, as well as the owners of the facilities, buildings, and premises, from and against any and all liabilities, claims, demands, costs, losses, expenses, or compensation of whatever nature in connection with any loss, damage, or injuries to persons and property caused or sustained by me, members of my family, my guests, pets, or companion animals. This release and the following indemnification includes any claims arising, in whole or in part from negligent acts or omissions of The Holt County Agricultural Society/ Holt County Fair, it's owners, agents, volunteers or employees. I agree for myself and for all minors for whom I am parent or guardian, for my heirs successors and assigns, that I shall defend, indemnify and hold harmless The Holt County Agricultural Society/ Holt County Fair, it's owners, agents, volunteers or employees from all losses, claims, expenses and demand, including attorney fees, that may be incurred by The Holt County Agricultural Society/ Holt County Fair, it's owners, agents, volunteers or employees, that are related, directly or indirectly , to my, or any minor for whom I am parent or guardian, use or participation in the services or activities provided by The Holt County Agricultural Society/ Holt County Fair, it's owners, agents, volunteers or employees. **The Holt County Agricultural Society/Holt County Fair does not carry or maintain any health, medical, disability, damage, or other liability insurance coverage for the benefit of its campers, and expressly disclaims any responsibility or obligation to do so. As a Camper, I am expected and encouraged by the Holt County Agricultural Society/Holt County Fair to maintain medical, health, and all other applicable insurance coverage for my own benefit. Proof of insurance to be provided to the Holt County Agricultural Society/Holt County Fair at or before the arrival to the Holt County fairgrounds.**

**I understand that Holt County Agricultural Society/Holt County Fair does not tolerate drunkenness, the appearance of drunkenness, loud arguing, threats or violence of any kind, or loud noises during quiet hours, or harassing or disturbing other campers. If, in the opinion of the staff, I am engaged in any of this, or anyone with me is engaged in any of this, all associated persons will be required to leave the campground immediately without a refund. All sites are presumed free of damage, broken glass, or other serious issues. If this is not the case, I must notify staff in writing within 4 hours of my arrival. Sites with significant cleanliness or damage issues will be subject to a service fee of \$50.00 or actual damages, whichever is greater.**

This Liability Waiver and Indemnity is binding on me, my heirs, agents, personal representatives, successors, assigns, and other persons acting or purporting to act on my behalf. My estate or I will reimburse the Holt County Agricultural Society/Holt County Fair for any and all costs and attorneys' fees in defending any lawsuits or claims filed by me or on my behalf.
