I understand and acknowledge that this Release discharges The Holt County Agricultural Society/Holt County Fair from any liability or claim that I may have against The Holt County Agricultural Society/Holt County Fair, with respect to any bodily or other injury, illness, death, or property damage that may result from my participation.
